Subject: Request to HEIs for identification of SWAYAM MOOCs for the January 2026 Semester.

आदरणीय महोदया/महोदय,

As you are aware, the SWAYAM Platform(www.swayam.gov.in) of the Government of India has, over the years, emerged as a key national initiative for expanding access to quality higher education for all. The SWAYAM Board, in its 27th meeting held on 30th October, 2025, under the Chairmanship of the Secretary (Higher Education), Ministry of Education, has approved a list of Massive Open Online Courses (MOOCs) to be offered in the January 2026 semester on the SWAYAM Platform. The list of these courses developed by the National Coordinators (NC), namely UGC, CEC, NPTEL, IGNOU, IIMB, AICTE, NITTTR, and Institutions of National Importance, is available on the SWAYAM portal (https://shorturl.at/QRcT7) and is enclosed herewith for ready reference. The last date for course registration, NC-wise, is also enclosed for ready reference. The Higher Education Institutions (HEIs) are requested to ensure that students complete their course registration on or before the respective last dates.

As per the UGC (Credit Framework for Online Learning Courses through SWAYAM) Regulations, 2021, the HEIs may allow only up to forty per cent. of the total courses, being offered in a particular programme in a semester, through the online credit course, through the SWAYAM platform. Further, HEIs that have adopted the above Regulations may allow their students to appear in the SWAYAM Course End-Term examinations at their own campuses, as per the UGC guidelines issued vide D.O.F. No. 1-8/2017 (SWAYAM) dated 27th August, 2024. This provision is in addition to the end-term SWAYAM Exam being conducted by NTA/NPTEL, and facilitates greater accessibility and flexibility for learners.

In order to ensure effective academic integration and optimal utilisation of these courses, in the January 2026 semester, you are requested to:

- Circulate the list of approved SWAYAM courses among Deans, Heads of Departments, SWAYAM University Nodal Officer (SWAYAM UNO) of your institution.
- Convene a meeting of the University/Institutional SWAYAM Advisory Committee to:
 - I. Identify and map relevant SWAYAM courses being offered in the January 2026 semester with existing programmes and syllabus;

- II. Finalise the mechanism for credit transfer and adoption in the January 2026 Semester;
- III. Display the approved list of SWAYAM courses on the university/institutional website/official Social Media handles for wider dissemination.

Your continued support and cooperation in successful implementation of the SWAYAM initiative is earnestly solicited.
